1	WHEREAS, Section 5-105 of the Education Article of the Annotated Code of Maryland
2	provides that a transfer between major categories of the budget of a County Board of Education
3	shall be made only with the approval of the County Council; and
4	
5	WHEREAS, Section 5-105 further provides that if a County Council fails to take action
6	on a written request for a transfer between major budget categories within 30 days of receipt of
7	the request, the failure to take action constitutes approval thereof; and
8	
9	WHEREAS, on May 24, 2023, the County Council adopted Council Resolution No. 69-
10	2023 that sets forth the Fiscal Year 2024 Operating Budget for the Board of Education; and
11	
12	WHEREAS, the County Council has received a request from the Board of Education to
13	transfer, in the Fiscal Year 2024 operating budget, a total of \$3,900,000 to the Student
14	Transportation Category from the Administration, Mid-Level Administration, Other Instructional
15	Costs, Student Personnel Services, Student Health Services, Operation of Plant, Maintenance of
16	Plant and Community Services Categories; and

18	WHEREAS, the County Council has also received a request from the Board of
19	Education to approve a supplemental appropriation in the amount of \$4,900,000 from its Fund
20	Balance to be added to the General Fund; and
21	
22	WHEREAS, this transfer and supplemental appropriation are necessary to fund
23	additional costs in the Student Transportation Category; and

25	WHEREAS, the Board of Education has indicated that the funds are available for
26	transfer and the Board of Education has indicated that the requested supplemental appropriation
27	from the School System's unassigned fund balance in General Fund is available for use in the
28	Board of Education's Fiscal Year 2024 Operating Budget.

30	NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County,
