Fiscal Impact:

The fiscal impact of removing the limit on the number of Speed Monitoring Systems in designated school zones includes monitoring costs of \$7,880 per month per Poliscan Unit. Currently, the total monthly cost of monitoring seven units is \$55,160. The cost for installation and moving of a Poliscan pad is included in the contract and is done as requested at no additional costs to the County.

The County receives the revenue from the fines collected resulting from Poliscan speed limit enforcement efforts. Per the Administration, there are currently 172 possible enforcement sites.

Purpose:

This legislation proposes to amend the Howard County Code to remove the limit on the number of Speed Monitoring Systems permitted within a designated school zone.

Other Comments:

Attachment A is a chart provided by the Administration showing the number of violations and how many violations were remedied by the fines collected by fiscal year since the program's inception in 2011.

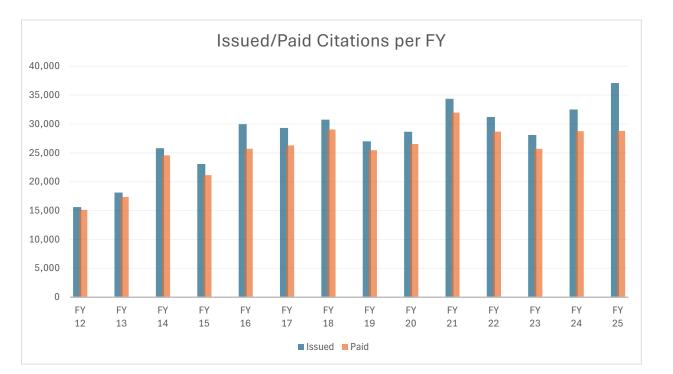
Attachment B is a chart provided by the Administration showing the Citation Revenue and Outstanding Citation fees since inception.
